





## HOW TO VIEW THE PANTHER DEGREE AUDIT (PDA) FOR LAW STUDENTS

To view your Panther Degree Audit, log into MyFIU at [my.fiu.edu](https://my.fiu.edu) with your Panther ID and Password.

The JD degree is earned with 90 credits, a cumulative grade point average minimum of 2.00, with a minimum of 58 credit hours in residence at the College; and, upon completion no earlier than 24 months and no later than 84 months after a student has commenced law study at the College of Law, or at a law school from which the College of Law has accepted transfer credit. No more than 6 credits of approved non-Law FIU graduate level classes earned with a grade of B or better will be accepted, except for students in an approved FIU Joint Degree program who may transfer 9 credits. Courses from an ABA accredited study abroad or an approved visiting/student exchange program must be earned with a grade of C or better to receive transfer credit.

**Description**

This course will advance students legal skills in analysis, research, objective writing, persuasive writing, and oral communications, and also raise new professionalism issues. In this course students will interview and counsel a client regarding a dispute and then research the legal issues raised by the dispute. Students will write a Complaint or Answer, a Demand Letter or Response Letter, an objective memo to a senior attorney describing the legal issues and their proposed course of action, and then prepare or respond to discovery requests. Students will mediate with opposing counsel to resolve the dispute, and will ultimately write a brief in support of their client's position.
