- I. Meeting called to order at 3:06 p.m.
- II. One Stop Updates.
 - (a) Luis mentioned that Fall D deadline has passed. Service hours at One Stop will be limited, closing at 5pm until January 2nd 2020. After this date, extended hours resume with 6 p.m. closure (5 p.m. on Fridays); 8 p.m. for online chat.
 - (b) End of term processing is underway: academic standing run to take place December 20th; January 9th 2020 is deadline to submit appeal. Financial adjustments for Pell will also take place without any adjustments for Fall D. Also, no payment cancellations for Fall D. Post Enrollment Registration Check (PERC) to run December 20th, Dean's list will be available on December 23rd and NC grades post. Loan disbursement scheduled for January 2nd with term limit hold preventing drops.
 - (c) Staffing update: David Kenton to return to BBC at which time they will be fully staffed.

III. CUAA Updates.
