- a. Silvana Rogelis, Director of Budgets, delivers projections for A&S funds for deliberations that sits at a total estimate of \$4,081,289
 - i. \$1,980,615 Allocated during budget deliberations on February 15th, 2023
 - ii. \$2,100,675 Pending to Allocate
- b. President Lugo reiterates that the total A&S allocation sits at approximately \$4million

IV. Deliberations

- a. SA Technology Center
 - i. Requested \$17,284
 - Senate President Pro-Tempore Stangl moves to go into a 5-minute discussion on SA Technology Center, President Lugo seconds. Motion passes.
 - 1. Senate President Pro-Tempore Stangl yields his time
 - 2. President Lugo states that the amount asked is to renew the license needed, and is in favor of fully allocating the requested amount
 - Senate President Sutton agrees with President Lugo and mentions the requested amount is appropriate
 - iii. President Lugo moves to end discussion, Senate President Pro-Tempore Stangl seconds the motion. Motion passes.
 - iv. President Lugo moves to temporarily allocate \$17,284 to SA Technology Center, Senate President Pro-Tempore Stangl seconds the motion
 - v. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

 - 4. Senate President Pro-Tempore Stangl mentions this office as a location for the distribution of Blue Books for students and events to enhance the student experience, thus favors fully funding this entity
 - 5. Vice President Casanova suggests a temporary allocation of \$142,000 for the sake of maintaining the hours and accounting for events
 - 6. President Lugo favors \$142,000
- iii. Vice President Casanova moves to end discussion, President Lugo seconds the motion. Motion passes.
- iv. Senate President Sutton moves to temporarily allocate \$142,000 to SGAMMC Office, Senate President Pro-Tempore Stangl seconds the motion
- v. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

- d. President Lugo moves to suspend the current order and moves to review Student Ambassadors, Senate President Sutton seconds the motion. Motion passes.
- e. Student Ambassadors
 - i. Requested \$41,462
 - ii. Senate President Sutton moves to go into a 6-minute discussion on Student Ambassadors, Senate President Pro-Tempore Stangl seconds. Motion passes.
 - 1. Senate President Sutton favors zero-funding this entity given that it has financial support from other means. He references that they have

- previously not received an allocation in the 2022-2023 fiscal year, and they have been able to maintain their programming
- President Lugo mentions that one of their signature events such as Trail of the Torch is conducted in collaboration with Homecoming and other organizations
- Senate President Pro-Tempore Stangl references the difficulty of allocating funds and hopes to see this entity continue to pursue funding from the Budget Committee
- iii. Senate President Pro-Tempore Stangl moves to end discussion, Senate President Sutton seconds the motion. Motion passes.
- iv. President Lugo moves to temporarily allocate \$0 to Student Ambassadors, Vice President Casanova seconds the motion

 - i. Requested \$113,940
 - ii. Senate President Sutton moves to go into a 5-minute discussion on the Student Bar Association, President President Lugo seconds. Motion passes.
 - 1. Senate President Sutton believes that an appropriate allocation would closely resemble their previous allocations from previous fiscal years and favors an allocation of \$80,000
 - 2. President Lugo mentions that an allocation of \$80,000 would allow for this entity to maintain programming and events
 - 3. Senate President Pro-Tempore Stangl reminds the committee that the FIU Law program has consistently performed with the best Bar pass rate in the State of Florida and advocates for a higher allocation
 - 4. Vice President Casanova echoes the sentiments of President Lugo and Senate President Sutton and states that there is simply not enough money to allocate for their requested amount, supports an allocation of \$80,000
 - iii. President Lugo moves to end discussion, Vice President Casanova seconds the motion. Motion passes.

 - 2. Senate President Sutton concurs with President Lugo

 - iv. President Lugo moves to temporarily allocate \$320,000 to SGA Room Rental Agreement, Vice President Casanova seconds the motion

 - President Lugo states that this entity already had their licenses paid for, he states that their programming is what they are requesting funding for, he supports zero-funding this entity
 - Senate President Pro-Tempore Stangl mentions that a majority of funding allocated by the committee is for programming, however he agrees with Senate President Sutton

 - i. Requested \$114,970
 - ii. Senate President Sutton moves to go into a 5-minute discussion on Student Life and Development, Senate President Pro-Tempore Senate President Pro-Tempore Stangl seconds. Motion passes.
 - Senate President Sutton believes that the estimated projections of \$4million made this difficult and kindly asks for departments not to rely on this committee to fund wages
 - 2. Senate President Pro-Tempore Stangl believes that the position that is being funded is important considering the need for an Associate Director of Alumni relations, he supports fully funding this entity
 - iii. President Lugo moves to end discussion, Vice President Casanova seconds the motion. Motion passes.
 - iv. President Lugo moves to temporarily allocate \$114,970 to campus life, Senate President Pro-Tempore Stangl seconds the motion
 - v. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

 - 1. President Lugo states that their requested amount should be reviewed appropriately given their importance

- 2. Governor of the Biscayne Bay Campus Barnd agrees and supports an allocation of approximately \$250,000
- 3. President Lugo agrees with Governor of the Biscayne Bay Campus Barnd and believes that an allocation of \$250,000 or \$260,000 is appropriate
- iii. Senate President Pro-Tempore Stangl moves to end discussion, Senate President Sutton seconds the motion. Motion passes.
- iv. Governor of the Biscayne Bay Campus Barnd moves to temporarily allocate \$255,000 to Student Media, Vice President Casanova seconds the motion
- v. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

m. Student Programming Council

- i. Requested \$693,663
- ii. Senate President Pro-Tempore Stangl moves to go into a 5-minute discussion on the Student Programming Council, Vice President Casanova seconds. Motion passes.
 - 1. Senate President Pro-Tempore Stangl mentions this entity is a very important one, given its high-quality programming and favors a fair allocation that resembles their requested amount closely
 - 2. President Lugo favors an allocation of \$600,000 given their success over the past years
 - 3. Senate President Sutton believes that an allocation of \$550,000 would be most appropriate
 - 4. Senate President Pro-Tempore Stangl reiterates that programming is a priority of this committee and offers a compromise of \$580,000
 - 5. President Lugo points out that this entity benefits all campuses and centers of the university and proposes \$580,000
 - 6. Senate President Sutton favors \$570,000
- iii. Senate President Pro-Tempore Stangl moves to end discussion, SenatePresident Sutton seconds the motion. Motion passes.
- iv. Senate President Pro-Tempore Stangl moves to temporarily allocate \$570,000 to campus life, Senate President Sutton seconds the motion

- v. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

 Motion passes with voice vote
- n. Success Courses and Peer Mentor Programs
 - i. Requested \$30,553
 - President Lugo moves to go into a 5-minute discussion on the Success Courses and Peer Mentor Programs, Vice President Casanova seconds. Motion passes.
 - President Lugo states that this program allows for mentoring and help from older students, however he finds it difficult to fully fund this entity
 - Governor of the Biscayne Bay Campus Barnd agrees and references their previous requests have been much smaller and supports zerofunding them
 - iii. Senate President Pro-Tempore Stangl moves to end discussion, Senate President Sutton seconds the motion. Motion passes.
 - iv. President Lugo moves to go into a 5-minute debate on temporarily allocating \$5,000 to Success Courses and Peer Mentor Programs, Senate President Pro-Tempore Senate President Pro-Tempore Stangl Seconds. Motion passes.
 - 1. President Lugo believes that an allocation of \$5,000 would benefit this entity and allow them to continue operating
 - Governor of the Biscayne Bay Campus Barnd also believes that it is important to allocate an amount that is similar to the 2022-2023 fiscal year
 - v. Vice president Casanova moves to end debate, Senate President Sutton seconds. Motion passes.
 - vi. President Lugo moves to temporarily allocate \$4,000 to Success Courses and Peer Mentor Programs, Vice President Casanova seconds the motion

- ii. President Lugo moves to go into a 5-minute discussion on Student tailgate Safety, Senate President Pro-Tempore Senate President Pro-Tempore Stangl seconds. Motion passes.
 - 1. President Lugo states that this entity is important to prevent injury and maintain safety during tailgating for students. He recognizes that this amount should be funded by Student Life and Development
- iii. Vice President Casanova moves to end discussion, Senate President Sutton seconds the motion. Motion passes.
- iv. Requested \$5,275
- v. President Lugo moves to temporarily allocate \$0 to campus life, Senate President Pro-Tempore Stangl seconds the motion

- p. University Wide Leadership Retreat
 - i. Requested \$25,000
 - ii. Senate President Sutton moves to go into a 5-minute discussion on the University Wide Leadership Retreat, Vice President Casanova seconds. Motion passes.
 - 1. Senate President Sutton yields the floor
 - 2. President Lugo states that this event brings all student leaders together to gain leadership skills and network, he supports fully allocating the requested amount to this entity
 - 3. Senate President Pro-Tempore Stangl supports fully funding the requested amount to this entity
 - 4. Senate President Sutton asks for clarification on what the amount allocated for this entity will be utilized for and suggests reducing the amount allocated to \$15,000 or \$20,000
 - 5. Executive Administrator Machado mentions that fully funding this entity would not be an issue
 - iii. President Lugo moves to end discussion, Executive Administrator Machado seconds the motion. Motion passes.
 - iv. Requested \$25,000

- v. President Lugo moves to temporarily allocate \$25,000 to campus life, Executive Administrator Machado seconds the motion
- vi. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

 Motion passes with voice vote
- q. Wellness and Recreation Services (MMC) Special Request
 - i. Requested \$31,650
 - ii. Senate President Pro-Tempore Stangl moves to go into a 5-minute discussion on the Wellness and Recreation Services, Senate President Senate President Sutton seconds. Motion passes.
 - 1. Senate President Pro-Tempore Stangl mentions that this entity is base funded and fulfilling this special request would be difficult
 - 2. President Lugo states that this special request will help fund additional sports and competitions for students
 - iii. Senate President Sutton moves to end discussion, Vice President Casanova seconds the motion. Motion passes.
 - iv. Senate President Sutton moves to temporarily allocate \$31,650 to campus life, Executive Administrator Machado seconds the motion
 - v. Comptroller Alvarez moves to vote through voice vote. The ayes have it.

 Motion passes with voice vote
- President Lugo moves to suspend the current order and moves to review the Registered Student Organization Council, Senate President Sutton seconds the motion. Motion passes.
- s. Registered Student Organization Council
 - i. Requested \$388,221
 - ii. President Lugo moves to go into a 5-minute discussion on the Registered Student Organization Council, Senate President Sutton seconds. Motion passes.
 - 1. President Lugo supports a temporary allocation of \$300,000 given the difficulty and reduced amount to allocate for all organizations
 - 2. Senate President Pro-Tempore Stangl mentions that smaller organizations will suffer

- 3. Senate President Sutton reminds the committee that a temporary allocation of \$300,000 is still an increase from their allocation from the 2022-2023 fiscal year
- 4. Vice President Casanova believes that it is wise to temporarily allocate \$300,000 because it is proportional to the amounts that have been allocated to other organizations
- 5. Executive Administrator Machado proposes a compromise of \$310,000
- 6. President Lugo highlights the difference between basic allocations and special allocations that are part of the requested amount
- iii. Senate President Pro-Tempore Stangl moves to extend discussion, Vice President Casanova seconds
- iv. Comptroller Alvarez calls for a Roll Call vote

- 4. Senate President Sutton reminds the committee that there are still a number of organizations that have been tabled and need to be temporarily allocated and supports \$310,000
- Executive Administrator Machado agrees with a compromise of \$310,000

 programming such as Meet Your Dean, and supporting smaller
 organizations through Senate Appropriations, however the line has
 not often been utilized thus supports a temporary allocation of
 \$25,000
 - Senate President Pro-Tempore Stangl supports the sentiments of President Lugo and believes that a temporary allocation of \$15,000 to \$20,000 is appropriate
 - 3. Senate President Sutton reminds the Budget Committee that the Senate has to approve the decisions made by the committee, and have historically turned down the budget due to Senate line items being lower than they liked, he believes it should not be lower than the requested amount
 - 4. Senate President Pro-Tempore Stangl believes that a \$20,000 temporary allocation is more than enough for this line item
 - 5. President Lugo proposes a \$35,000 compromise
 - iii. President Lugo moves to end discussion, Senate President Pro-Tempore Stangl seconds the motion. Motion passes.
