A BILL

To give a cover page to the Constitution and to replace the cover page of the Statutes.

Be it enacted by the Senate of the Student Body at Florida International University assembled,

Whereas, The Constitution does not have a cover page,

Whereas, The Statutes should have a simple and aesthetically pleasing cover page,

Whereas, The Senate Rules do not have a cover page,

Whereas, The cover pages for the Constitution, the Statutes, and Senate Rules should match,

Now Therefore, the Senate of the Student Body replaces the first page of the Student Government Statutes with the attached “STATUTES” cover page;

Now Therefore, the Senate of the Student Body hereby adds the attached “CONSTITUTION” cover page to be in front of the Student Government Constitution;

Now Therefore, the Senate of the Student Body hereby adds the attached “SENATE RULES” cover page to be in front of the Senate Rules of Procedure.
