A BILL

To give a cover page to the Constitution and to replace the cover page of the Statutes.

Whereas, The Senate Rules do not have a cover page,

Now Therefore, the Senate of the Student Body hereby adds the attached "SENATE RULES" cover page to be in front of the Senate Rules of Procedure.
