- i. Sen. Salup-Cid gave the outline of the bill.
- ii. Sen. Lachapelle moved for a 5-min Q&A, passed.
- iii. Sen. Barriga: asked whether it will be a single stall or multiple stalls, where they will be built and whether they will replace existing restrooms. Sen. Salup-Cid: existing gender-neutral restrooms to be converted to comply with requirements.
- iv. Sen. Stone: asked about amendments, likes a lot of aspects of the bill, proposes to tone down the calling out of the state administration and the inclusion of the demand term; proposes rewording to benefit the students. Sen. Salup-Cid: the bill was discussed with students, would be amendable if the nature of the resolution is kept.
- v. Sen. Lachapelle: would like the bill to unite the students, wants students to be seen as humans, amendment is up to the Senate.
- vi. Sen. Brown: asked about MMC/BBC implementation and implementation in housing buildings, asks for clarification on not building new bathrooms. Sen. Salup-Cid: the intention is for university-wide implementation; the proposal to turn each bathroom stall into a separate room, the architecture team considers implementation possible.
- vii. Sen. Lachapelle: the implementation considers long-term plan and fiscal effectiveness, for new buildings it would be included in design.
- viii. Sen. Dawson moved to extend Q&A by 3 min, passed.
- ix. Sen. Dawson: asked for amendment to remove the name of the FIU President, Sen. Salup-Cid: agreed.
- x. Sen. Brochinsky asked about producing 2 restrooms per building since some buildings have limited number of restrooms.
- xi. Sen. Lachapelle: one bathroom is not enough since it can be inaccessible, at least 2 was proposed for this reason.
- xii. Sen. Salup-Cid asked clarification on the number of restrooms, Sen. Brochinsky clarified.
- xiii. Sen. Stone: motioned to extend Q&A by 5 min, passed.
- xiv. Sen. Stone: asked about wording the bill as for the State of Florida Legislation, Sen. Salup-Cid: the entire floor of the government is involved, willing to

- consider the change; transgender students experience difficulties with restroom access.
- xv. Sen. Lachapelle: bathroom access is one of the biggest issues mentioned by transgender/queer students.
 - xvi. Sen. Vogel: considers the bill important; the bill is about inclusivity, ADA restrooms in fact are not always compliant and not possible to use, this impacts access to education.
 - xvii. Sen. Campbell motioned for a 4-min discussion, passed.
 - xviii. Sen. Stone: considers the bill important for student comfort, would like the support of the student body, thinks the wording may be too political for some students to support the bill; would like to work together to make the bill palatable to all students.
 - xix. Sen. Campbell: the bill is about empathizing with other students, is not political but about basic needs.
 - xx. Sen. Salup-Cid understands the reservations about calling out the officials, but thinks the context is necessary and there is a need to talk about it.
 - xxi. Sen. Lachapelle moved to extend the discussion by 3 min, passed.
 - xxii. Sen. Lachapelle: is one of the first transgender persons to serve, politization was not warranted. Will share resources for further access; the bill is intersectional and not only about LGBTQ community.
 - xxiii. Sen. Vogel: the matter is not political, is about basic human rights and inclusivity, and addressing basic needs.
 - xxiv. Sen. Stone moves to extend the discussion by 5 min, passes.
 - xxv. Sen. Stone: would like the resolution to pass but feels that supporting students can be done without putting the Governor's name on the bill.
 - xxvi. Sen. Barriga: would like more discussion on which bathrooms will be replaced, and numbers of stalls vs. number of bathrooms, as well as the coordination of the enactment.
 - xxvii. Sen. Salup-Cid: the administration needs to be involved in the implementation through communication with SGA, clarified the planned restroom design proposal.
 - xxviii. Sen. Lachapelle: starting the process was about demonstrating SGA support and starting the dialogue, initial projects are small, cost-effective.
