1. Motion to just read title passed. Salup Cid says that this bill can benefit a lot of students. La Chapelle says that there is extreme lack of disabled student representation, and this will really help. Q/A: Campbell asks what percentage

of budget we will give to DSU. Answer was we do not know because they have not met with budget committee yet, but around 3,000-5,000\$ to start off. Arzola asks what the specific need is. Answer: DRC is limited in ability to provide big solutions, but if DSU is present, they can help with big issues that the DRC cannot. Motion to extend Q/A by 5 min passed. Brochinsky asks, can we get examples of what DSU has done in past and how does bureau status help? Answer: DSU has only existed for one semester. They have helped make events accessible. Bureau will help advocate even farther and gain more representation/change. Way asks what the main goal is aside from advocating for disabled students? No other organization was able to mobilize students as well as DSU in one semester. Goal is to increase representation advocacy, and resources. Motion for roll call vote passed.
