B. S.B. 04 021 – Election Streamlining

- i. President Sutton read the first part of the bill.
- ii. Sen. Hernandez moves to read only the edited changes, motion passes.
- iii. President Sutton read the edited changes in the bill.
- iv. President Sutton gave an opening statement: some changes required by revised Constitution, and some introduced due to prior election challenges.
- v. Sen. Lachapelle: the purpose was to increase engagement and make elections run smoother.
- vi. 5 min Q&A: Sen. Brochinsky: ask about BBC candidates information sessions and changing party affiliation related to dropping the party, as well as voting through FIU-run website. Pres. Sutton: BBC sessions can be added, were held over Zoom in the past, no chairperson approval required for dropping the party.
- vii. Open to discussion on the last matter, the interface on mobile is difficult to navigate, third-party election software is easier to use.
- viii. Sen. Stone asked about the number of people on the elections board, Sen. Lachapelle: the matter is about procedures.
- ix. Sen. Stone moves to enter a 5-min discussion, motion passes.
- x. Sen. Stone: there was a clause regarding violation before, should be a  $\frac{3}{4}$  majority. The current online system works well as can be streamlined within FIU.
- xi. Sen. Salup-Cid asks about the third-party option, Pres. Sutton: currently phrased as it has to be run through a third party, can be revised.
- xii. Sen. Brochinsky: the online voting issue could be solved with the IT department, would not support third-party software use.
- xiii. Sen. Salup-Cid asks whether third-party software could be included as an option.
- xiv. Sen. Barriga: believes that technical issues could be resolved, can look into options, and do a test run.
- xv. Sen. Lachapelle: suggests not requiring the use of third-party software for more flexibility, suggests discussion on the unanimous consent.
- xvi. Sen. Brochinsky moves to extend by 5 min, motion passes.
- xvii. Sen. Brochinsky: suggest changing to supermajority 4 out of 5 votes.

- xviii. Sen. Stone: agrees with the supermajority proposal, introducing a third party for voting would cause confusion and take away opportunities to fix the software, third-party switch is going to take time, process can be straightened.
- xix. Pres. Sutton: does not feel strongly about the unanimous decision, if the Senate would like to amend the procedure amendments can be made but the procedure worked in the past; conversation on the third-party software use can be held, opinion of the advisors to be taken into account.
- xx. Sen. Brochinsky: asks for a reading of amendments.
- xxi. Sen. Lachapelle read the amendments regarding the supermajority vote proposal and third-party voting software option.
- xxii. Sen. Brochinsky moves to extend the discussion by 2 min, motion passed.
- xxiii. Sen. Brochinsky: has an amendment about information sessions to include in-person on either campus or virtual sessions, dropping affiliation without the consent of party chair.
- xxiv. Sen. Lachapelle: all proposed amendments recorded.
- xxv. Sen. Salup-Cid asks about whether dropping the party would require consent of the party chair, Sen. Brochinsky: the opposite, no consent required to drop.
- xxvi. Pres. Sutton: agrees with proposed amendments.
- xxvii. Sen. Stone: suggests removing third-party software proposal, believes that improvement can be made, third-party software use can cause issues such as tampering, approval process can take a long time.
- xxviii. Sen. Salup-Cid moves to enter a 5-min discussion on removing the third-party proposal, motion passes.
- xxix. Sen. Salup-Cid thinks there is no issue of having the third-party option on the table to streamline the election, considers the probability of election tampering low.
- xxx. Sen. Barriga: agrees with Sen. Salup-Cid to keep a third-party option.
- xxxi. Sen. Brochinsky: option for third-party software can be kept but does not have to be used.
- xxxii. Sen. Stone: thinks that the system works well and adding options is unnecessary.
